RV Camper Application and Regulations

RHINEBECK ANTIQUE CAR SHOW & SWAP MEET May 5 – 7, 2017

Please Note: The DC Fairgrounds is not a public campground therefore; camping is limited to event participants, first come first serve. It is not available to show spectators.

To pre-register for camping, the cost is \$30.00 per night. On-site registration will be \$50.00 per night, pending availability.

1. Camping is for event participants only from 8am Fri. May 5 - Mon. May 8, 2017. **All campers must be removed by 10am Mon. May 8th.**
2. No tents or outside camping allowed.
3. Dumping facilities are NOT available; however, pumping is available for \$40 cash fee. This fee is paid separately from all other fees.
4. Pets are not allowed inside the Fairgrounds at any time. They can be housed inside travel trailers; they cannot be left chained and unattended outside. All pets must have valid & current rabies vaccinations.
5. Open awnings are not permitted.
6. No liquids of any kind are to be dumped or poured onto the ground. Please make sure all hose fittings are tight to prevent leaks or sprays (strictly enforced).
7. Vacuum Breakers must be left on water spigots.
8. No open flames of ANY kind, under any circumstances, are allowed, including candles, torches, campfires, barbeque or gas grills.
9. DCAS Inc. reserves the right to revoke any permit for failure to abide by these rules and regulations. If a permit is revoked, no refunds will be issued and you must vacate the property immediately.
10. DCAS Inc. reserves the right to make a ruling on any questions not contained in these rules and regulations.
11. Returned checks will be charged a \$30 processing fee.
12. REFUND POLICY: Refunds will be made if cancellation is made within 48 hours of event. There is a 10% charge for a cancellation.

Your permit will NOT be mailed to you. Please provide us with an email address if you would like to receive an email that your application has been received by this office.

Anyone caught violating the above regulations will be asked to leave immediately. The above regulations will be enforced by the Dutchess County Department of Health and a fine of up to \$1,000.00 per day per violation will be imposed. The camper registrant will be responsible for paying this fee.
